Anthem, Inc. provides life, hospital and medical insurance plans. It offers a broad spectrum of network-based managed care health benefit plans to the large and small employer, individual, Medicaid, and Medicare markets. The company operates through the following segments: Commercial & Specialty Business, Government Business, IngenioRx and Other. The Commercial and Specialty Business segment includes local group, national accounts, individual and specialty businesses. The Government Business segment includes Medicare and Medicaid businesses, national government services and services provided to the federal government in connection with federal employee programs. The IngenioRx Business segment includes PBM services to affiliated health plan customers, as well as to external customers outside of the health plans. The Other segment includes Diversified Business Group (šDBGš), which is an integrated health services business. Anthem was founded on November 30, 2004 and is headquartered in Indianapolis, IN.
