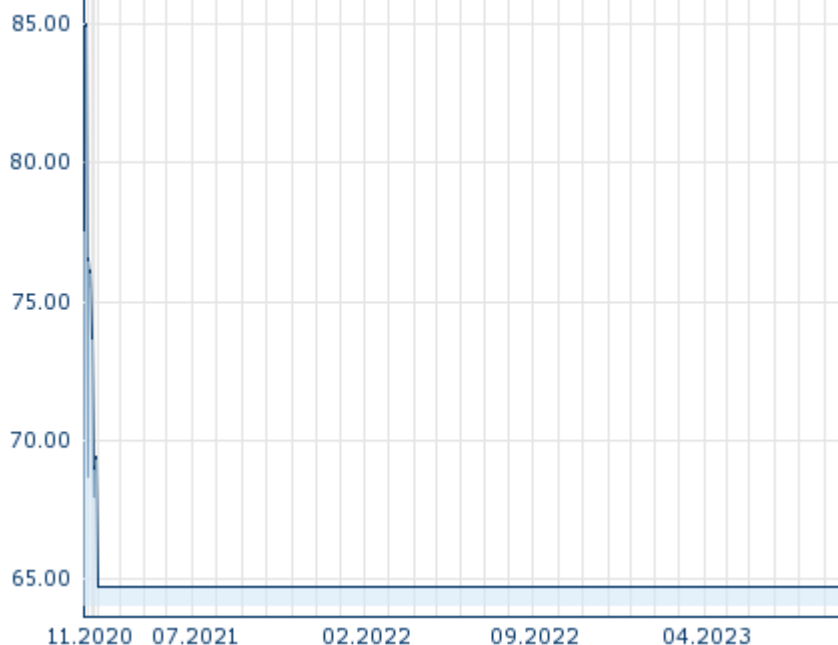

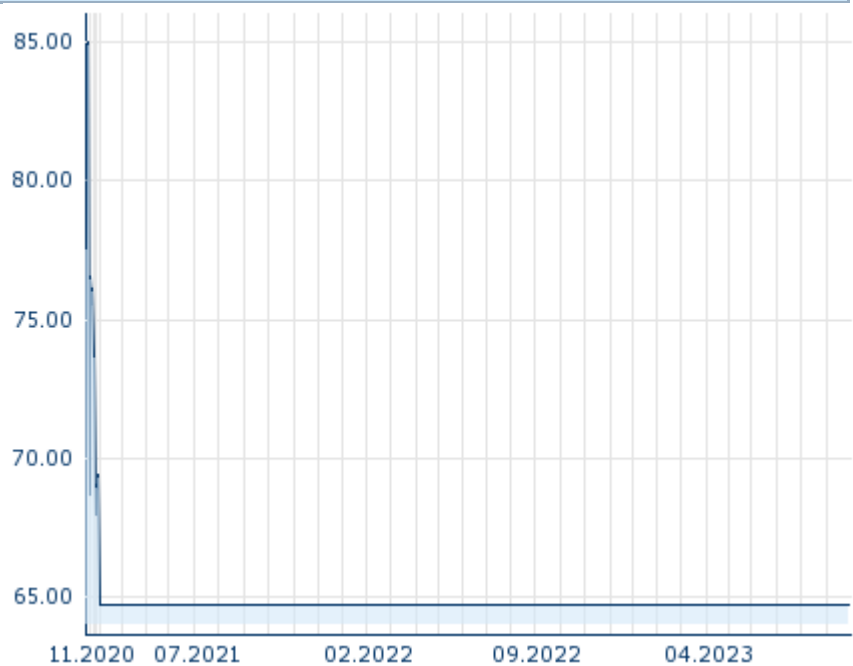

Allegro.eu SA operates as a holding company which engages in the management of e-commerce platforms. It operates through the following segments: Allegro, Ceneo, and Other. The Allegro segment consists of the B2C, C2C, and B2b e-commerce platform, comprising Allegro.pl, Allegro Pay, Allegro Finance, Opennet.pl and, starting from October 2021 X-press Couriers and SkyNet Customs Brokers. The Ceneo segment comprises of a price comparison platform in Poland allowing users to compare consumer products from various Polish e-stores. The Other segment refers to mainly of the results of eBilet and the costs of the holding companies. The company was founded on May 5, 2017 and is headquartered in Luxembourg.
