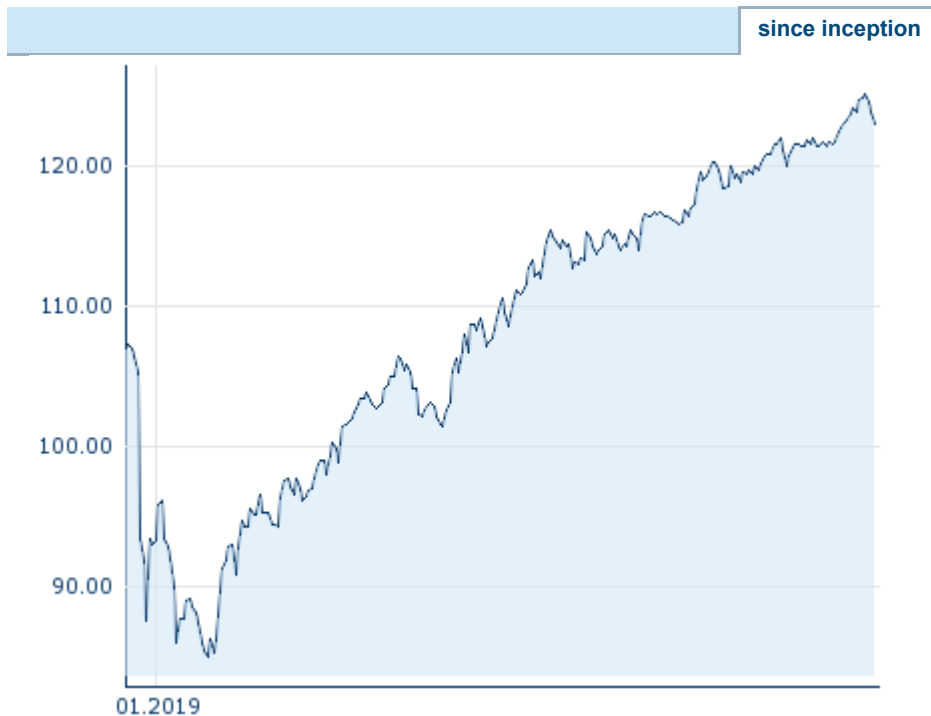

Index/Participation Certificates | Description

With an index certificate, investors directly participate on the development of the underlying instrument. It allows to diversify the risk, since the investment is not in one specific security, but in an index. This way the investment is not influenced by the fluctuations in one security, but by the combined development of all the securities contained in the index. Index certificates are issued at a certain exchange ratio relative to the underlying instrument. Most often they are traded at 1:100 or 1:10 to the index.
