In exchange for a one time up front payment, the option premium, the Interest Cap Warrant limits your interest charge, while you are still able to benefit from low rates. Caps are available with various strikes, maturities and

redemption schedules, fitting to your EUR financing. If you do not have a sound opinion on the future interest development and want to limit your risk, while at the same time you want to benefit from low rates, the Interest Cap Warrant is the ideal instrument.

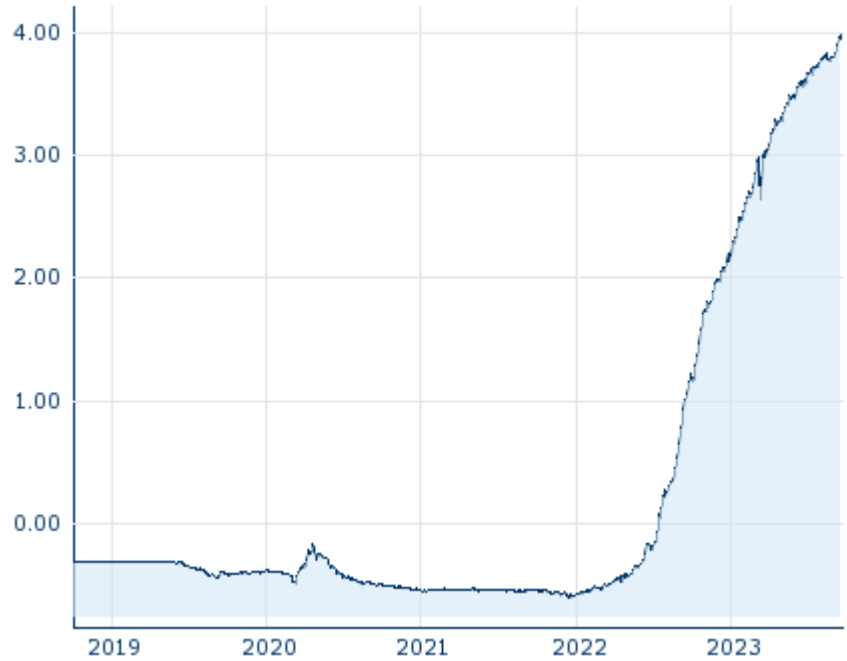
