There is an automatic early redemption, if the closing price of the EURO STOXX® Banks Price Index is at or above the redemption barrier on one of the valuation dates. In this case investors receive the respective early redemption amount (100.00 % + 6.25 % for each year) on the repayment date (27/07).

If the Express-Bond has not been redeemed on any of the previous early repayment dates, there are two possibilities at maturity:

1. If the closing price of the EURO STOXX® Banks Price Index is at or above the final-redemption-barrier on the last valuation date (20/07/2023), then investors receive the nominal amount of 100 % + 31.25 % (equals 5 x 6.25 %).
2. If the closing price of the EURO STOXX® Banks Price Index is below the final-redemption-barrier on the last valuation date (20/07/2023) then investors receive a redemption amount according to the performance of the index. There is no interest payment at maturity. In this case there is a capital loss.
