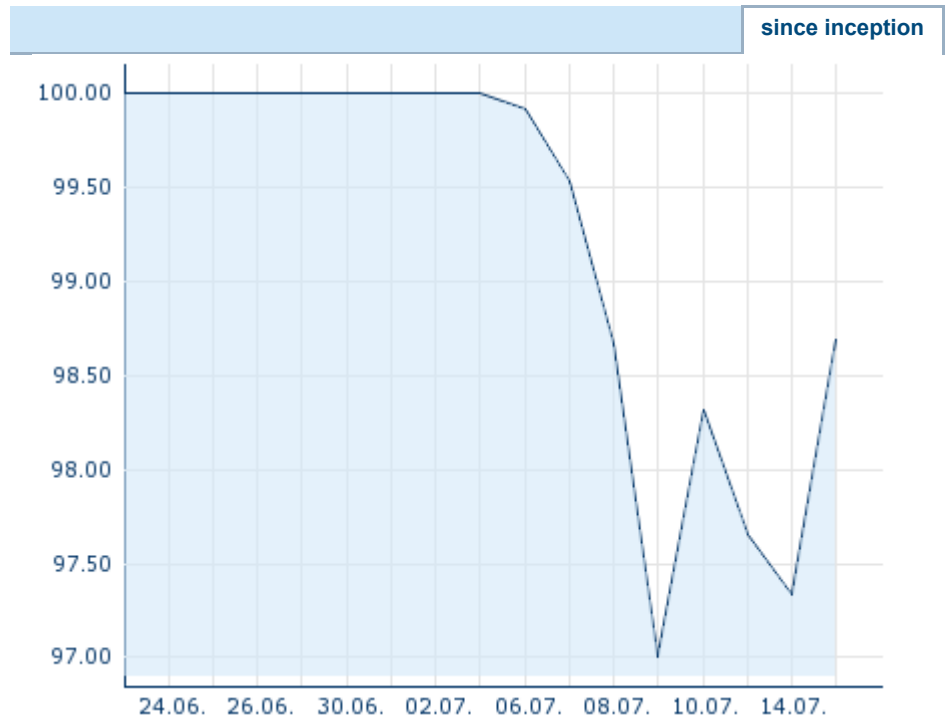

#### Reverse convertibles | Description

This protect pro reverse convertible bond refers to the share of Erste Group Bank AG (underlying). It has a fixed term (maturity date: 06/07/2021) and a risk buffer (= barrier; "protect pro"). At maturity investors receive an interest payment of 9.00 % p.a. based on the nominal amount regardless of the performance of the underlying.

The repayment of the nominal amount upon maturity depends on the performance of the underlying.

1. The underlying is at or above the barrier (80.00 % of the strike price) on the valuation date (02/07/2021). In this case investors receive the nominal amount.

2. The underlying is below the barrier on the valuation date. Investors then receive shares of Erste Group Bank AG according to the ratio (nominal amount / strike price). Fractions of shares are settled in cash.

The issuer and its affiliates may - without being obliged to - act as market maker for the underlying.
