Express bonds | Description

This express bond refers to the share of OMV AG. Regardless of the performance of the underlying, there is an annual interest payment of 4.25 % p.a. The bond will be redeemed on 02/09/2024 if there is no automatic early redemption.

There is an automatic early redemption, if the closing price of the underlying is at or above the strike price on one of the valuation dates (26/08/2021, 26/08/2022, 28/08/2023). In this case investors receive the respective early redemption amount of 100.00 % on the repayment date (02/09).

If the express bond has not been redeemed early, there are two possibilities at maturity:

1. If the closing price of OMV AG is at or above the final-redemption-barrier on the last valuation date (26/08/2024), investors receive 100.00 % of the nominal amount plus the interest payment of 4.25 % p.a. for the last year.
2. If the closing price of OMV AG is below the final-redemption-barrier on the last valuation date, then investors receive a predetermined number of shares of the underlying, in addition the interest rate of 4.25 % p.a. for the final year is paid. Fractions of shares are settled in cash. In this case there is a capital loss.

The issuer and its affiliates may - without being obliged to - act as market maker for the underlying.

Secondary market
