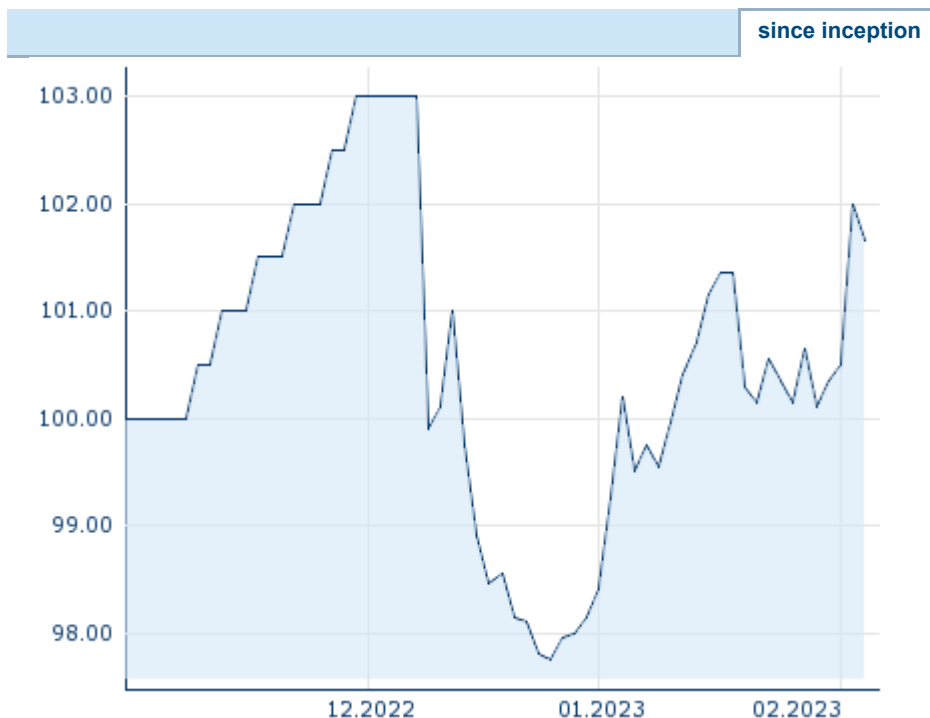

The ERSTE Green Invest Garant 122% 22-30 is a bond of Erste Group Bank AG with a fixed term of 8 years. The underlying of the bond, the Solactive ERSTE Green Invest Index VC, invests broadly diversified in sustainable topics such as society and environment.

The redemption at maturity depends on the performance of the Solactive ERSTE Green Invest Index VC. In case of a positive performance of the index, investors receive the performance of the index in addition to the minimum redemption price. In case of a negative performance the capital guarantee applies and investors receive 122% of the nominal amount (minimum redemption price).

With the ERSTE Green Invest Garant 122% bond investors have the opportunity to invest with just one product in sustainable companies selected according to strict environmental, social and ethical criteria and to contribute to the protection of the environment and resources.

The asset allocation of the portfolio with 60% global equities and 40% Euro-bonds aims to balance long-term return and expected risks as well as possible.
