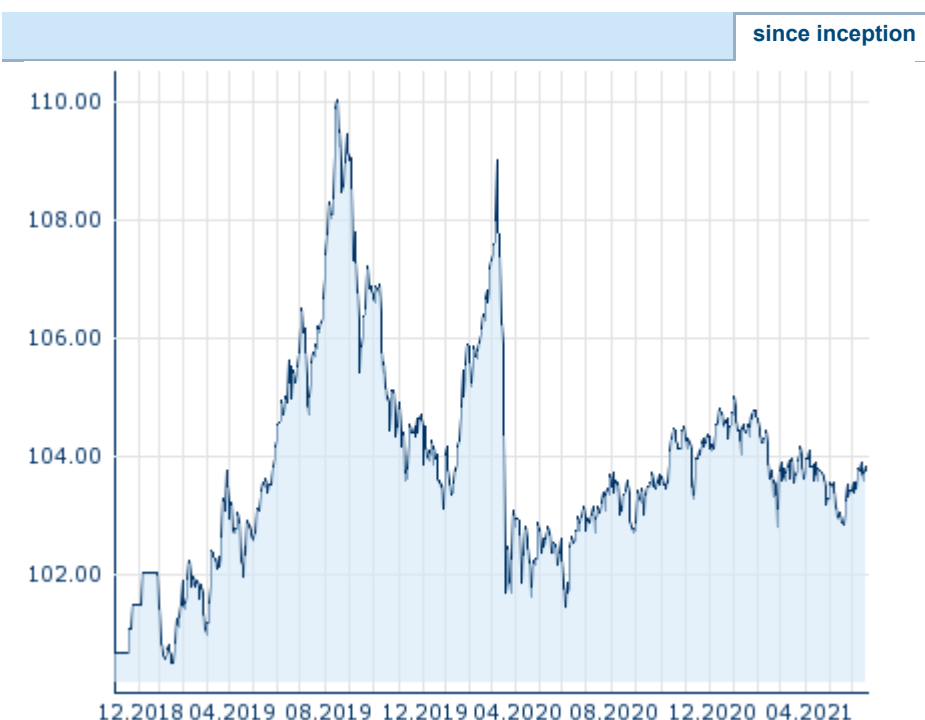

## Description

The s Wohnbaubank fixed-rate bond pays the interest quarterly. The amount of interest paid is fixed and thus independent of development of the interest rates in the capital markets. The bond is redeemed at maturity at nominal value. As a trustor, Erste Bank der oesterreichischen Sparkassen AG is liable to the issuer (trustee) for the interest payments and the redemption at maturity. Interest income from residential convertible bonds of up to 4 % is exempt from capital withholding tax.

## Conflicts of interest

Erste Group Bank AG or affiliated companies (collectively "Erste Group") are involved in the share capital of s Wohnbaubank AG. Furthermore employees of Erste Group are in the Supervisory Board of s Wohnbaubank AG. The interests of the Erste Group and those of the bondholders may differ. #### Payment notes

This bond pays a coupon of 1.35 % p.a., interest is paid on 06/03, 06/06, 06/09 and 06/12 of each year, the first interest payment is on 06/12/2018.

#### Settlement

Redemption is on 06/09/2029 at 100 %, if there is no conversion (issuer risk).

#### Secondary market

During the term it is possible to sell the product during the trading hours at the exchanges, where the product is listed.
