Company Profile

Continental AG is a holding company, which engages in the manufacture and sale of soft rubber products, rubberized fabrics, and solid tires. It operates through the following segments: Chassis and Safety, Powertrain, Interior, Tires, ContiTech, and Other/Consolidation. The Chassis and Safety segment integrates intelligent systems to improve driving safety and vehicle dynamics. The Powertrain segment offers clean vehicle drive system. The Interior segment develops components and end-to-end systems for connected mobility. The Tires segment involves reduction of fuel consumption by minimizing rolling resistance. The ContiTech segment covers the development, manufacture, and market of products for the machine and plant engineering, mining, and automotive industries. The Other/Consolidation segment represents the centrally managed subsidiaries and affiliates including holding, financing, and insurance companies. The company was founded on October 8, 1871 and is headquartered in Hanover, Germany.
