

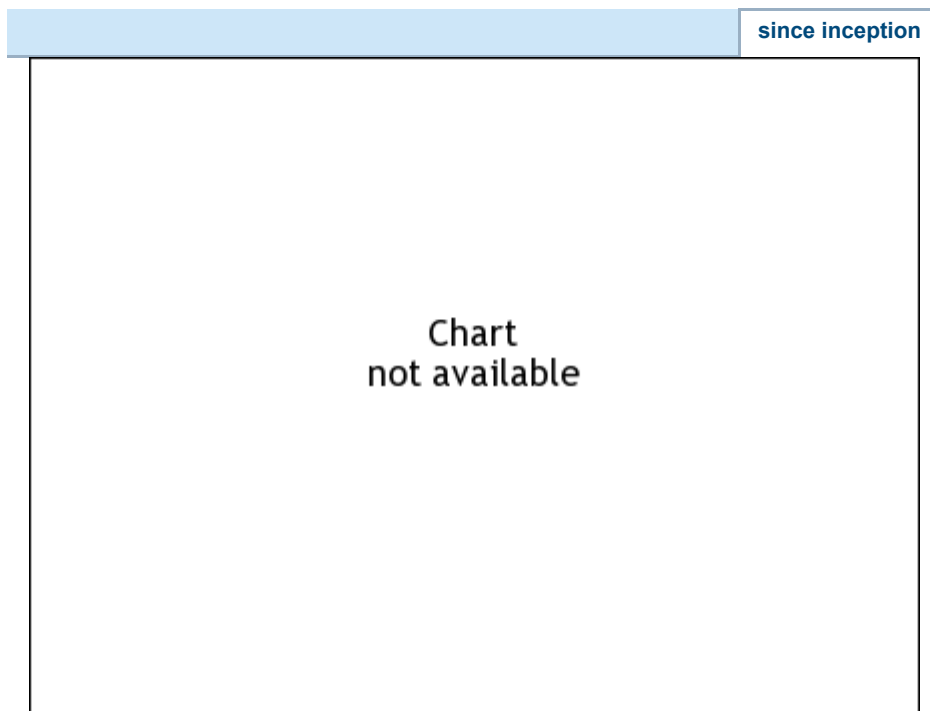

#### Express bonds | Description

This express bond of Vontobel Financial Products GmbH refers to the EURO STOXX 50® index. The bond will be redeemed on 05/03/2026 if there is no automatic early redemption.

There is an automatic early redemption, if the final price of the underlying is at or above the redemption barrier (100.00 % of the strike price) on the valuation date (28/02/2022, 27/02/2023, 27/02/2024, 26/02/2025). Then the early redemption amount of 100.00 % of the nominal amount plus 4.00 % for each year is paid.

If the express bond has not been redeemed early, there are two possibilities at maturity:

1. If the final price of EURO STOXX 50® index is at or above the final-redemption-barrier on the last valuation date (26/02/2026), investors receive 100.00 % of the nominal amount plus the interest of in total 20.00 % (= 5 x 4.00 %).
2. If the final price of EURO STOXX 50® index is below the final-redemption-barrier on the last valuation date, investors receive units of the iShares Core EURO STOXX 50 UCITS ETF (DE) determined on the last valuation date. There is no interest payment upon maturity. In this case there is a capital loss. The number of deliverable ETF units is calculated as the nominal amount multiplied by the performance of the underlying divided by the net asset value of the ETF. Fractions of units are settled in cash.
